The exemptions are subject to periodic review by the federal and state taxing authorities and management is confident that the Agency continues to satisfy all federal and state statutes in order to qualify for continued tax exemption status. The Agency may periodically receive unrelated business income (such as sublease rental income) requiring the Agency to file separate tax returns under federal and state statutes. Under such conditions, the Agency calculates, accrues and remits the applicable taxes.

Criminal Justice Program

The Animal Legal Defense Fund's Criminal Justice Program is staffed by attorneys, including former prosecutors, with expertise in animal protection. Criminal Justice Program attorneys provide free legal assistance and trainings to prosecutors, law enforcement agencies, and judges to ensure that state criminal anti-cruelty statutes are vigorously enforced and that those convicted of animal cruelty and neglect receive appropriate sentences. They work with state legislators to enact felony anti-cruelty statutes in states that do not yet have them and to upgrade existing laws in states that do. The criminal justice program also maintains a nationwide database of animal cruelty cases and current and model animal protection laws available to prosecutors, legislators, and researchers.

Legislative Affairs Program

The Animal Legal Defense Fund's other legal programs include Legislative Affairs. Efforts focus on working at state levels to advance legislation that would promote or protect the lives and interests of animals or to oppose legislation that would be detrimental to animals' well-being. As part of the Animal Legal Defense Fund's Animal Law Program, the organization makes grants available to various organizations, law centers, individuals, and Animal Legal Defense Fund Student Chapters at law schools across the country to support the efforts to inform, educate, and take action for animal protection laws. The Animal Legal Defense Fund grants are critical to encouraging the next generation of animal lawyers. Grants and scholarships funded during the year ending December 31, 2018, included various donations to law schools, organizations, and individuals.

#### Pro Bono Program

The Animal Legal Defense Fund's Pro Bono Program is the nation's largest pro bono network for animal protection. The program partners with attorneys and pro bono coordinators across the United States to expand the practice of animal law. Collectively, legal professionals donate thousands of hours to the Animal Legal Defense Fund's cases annually. The donated value of services for 2018, included in the total expenses of the Pro Bono Program, was \$4,543,585. The program also works to increase the understanding of animal law in the legal community by educating professionals at law firm and bar association events and keeping volunteers engaged and up-to-date on the latest developments in the field.

#### Special Programs

Special Programs funds investigations of factory farms, puppy mills, and roadside zoos, in order to substantiate evidence for civil litigation and potential criminal investigations. This program also provides grants and sponsorships to other

Public education informs the public of, and facilitates support for, the organization's mission in protecting the lives and advancing the interests of animals through the legal system.

A representative of management authorizes the final Form 990 which is then e-filed with the Internal Revenue Service.
